Thank you for volunteering with THE MILO FOUNDATION. In order to protect our organization and our rescued animals, we ask that you sign this waiver.

Although every attempt will be made to ensure your safety, animals (particularly rescued animals, specifically dogs and cats) are by their nature unpredictable in behavior. Accordingly, you, as a volunteer, agree to the following conditions:

1. I represent that I am 18 years of age or older and legally capable of entering into this agreement. I further agree to cooperate and conform with the directions, policies, rules and instruction from the personnel of THE MILO FOUNDATION.
2. I am not aware of any medical condition which would render it inappropriate for me to participate as a volunteer for and at the MILO FOUNDATION, and I assume the risk of any unknown medical condition I may have that might be affected by THE MILO FOUNDATION.
3. I am aware that as a volunteer of THE MILO FOUNDATION I am acting as a representative of the organization and agree to act responsibly at all times by maintaining a professional demeanor and protecting the organization's rescued animals from any harm by practicing common sense while they are in my possession.
4. I hereby give permission to the physician, health care provider selected by THE MILO FOUNDATION calling the emergency services as a result of personnel present to render medical treatment deemed necessary and appropriate by the physician or health care provider.
5. As consideration for me being permitted to participate in THE MILO FOUNDATION I agree to forever release, discharge and hold harmless from any legal and/or other liability and agree not to sue THE MILO FOUNDATION its employees, agents, representatives, members, shareholders, officers, directors, coordinators, staff, parents, volunteers, assigns, heirs, next of kin, and/or estates (hereafter collectively "THE MILO FOUNDATION") arising out of any liability, costs, fees, damages, judgments, injuries, physical or psychological, death, or personal or real property damage resulting from my participation in volunteering at THE MILO FOUNDATION whether or not such liability, costs, fees, damages, injury, or death was caused by the negligence, active or passive, or default of THE MILO FOUNDATION.
6. I understand that my participation in volunteering at THE MILO FOUNDATION involves risks of injury, including, but not limited to, falls, loss of control, bites, scratches, collisions, accidents, and physical and/or psychological injuries and I agree to assume all risks and all liabilities connected with volunteering at THE MILO FOUNDATION.

I, _____ hereby agree to hold THE MILO FOUNDATION, its officers, directors, employees, and other volunteers forever harmless for any injury whatsoever that I may suffer as a result of my volunteer activities with THE MILO FOUNDATION. This includes but is not limited to dog bites, scratches, communicable illnesses or pests contracted from any animal.
8. I agree that any animal rescued by THE MILO FOUNDATION is owned solely by and is the property of THE MILO FOUNDATION, and as a volunteer of this organization, I will not withhold, sell, or give away any animal entrusted to me by the organization.
9. I will not rescue any animal as a stray or a shelter in the name of THE MILO FOUNDATION without prior authorization from a director, officer or employee of the organization.

I understand and agree that this Release and Waiver of Liability form relates to and binds the undersigned, including my family, heirs, assigns, agents, legal representatives, administrators, trustees, estates and any other interested person(s) or entity.

I have read the Release and Waiver of Liability form and fully understand its terms, and understand that I have given up substantial rights by signing it and have signed it freely and voluntarily. And I intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
